EAGLES BRING NEW CHALLENGES TO LOONS

As eagles return to NH, there have been frequent accounts of eagle/loon showdowns. Eagle predation of loon eggs and nests is less frequently reported than attacks on chicks, but several attempts of eagles trying to grab loon chicks have been documented recently. Are these recent showdowns and predations a sign of things to come? Indeed. Washington State has over a thousand breeding bald eagles, and they routinely put a big dent in the annual breeding success of a small loon population. This Fall I witnessed our two "teenage" loons ward off an eagle through yodeling and diving.

Wingspan - 72 to 90".

Can fly to an altitude of
10,000 feet.

At level flight they can
achieve speeds of 30-35 mph.

Lifting power - 4 lbs.

THE PLA MATCHING FUND

The Lake Host Program is perhaps the most important program we have aimed at preserving the quality of Pleasant Lake. We all owe him a great deal of thanks for his years of service helping protect what we have. As a result of his departure, we are in desperate need of someone to take over the reins. The second issue is that it appears that there will be no federal funds provided to the state to support this program. At best we could see a significant cut in the financial support provided by the state. At worst we could receive no funding at all.

Put Your Property On a Low Salt Diet This Winter

Chloride levels in New Hampshire's fresh waters are 100 times more today than they were 50 years ago before salt was used to melt ice on roadways.

Our water resources are being inundated with chloride from many sources. Water runoff from local roadways, parking areas, driveways, walk-ways, salt storage areas, and discharges from water softening systems from regional water suppliers and individual homeowners all contribute to the problem. This creates quite a challenge for reducing salt use and protecting water quality in New Hampshire. Unlike other pollutants, salt cannot be treated or removed from runoff.

Our only option to restore our water quality is to reduce our salt use. The New Hampshire departments of Environmental Services and Transportation are working with the United States Environmental Protection Agency to study chloride levels in certain regions of the state and identify needed reductions to improve water quality. While these organizations will be taking appropriate actions themselves and working with area communities to reduce salt use, each and every property owner should take action to reduce his/her contribution to this problem. The PLA participates in the DES Weed Watchers Program, taking a proactive approach to exotic plant control. Weed infestations lead to diminished wildlife habitat, decreased recreational potential, and lowered property values. Volunteers are instructed on how to take a weed survey, what to look for, and who to contact if there is a problem. Anyone can become a Weed Watcher. The only equipment a volunteer will need is a boat, a partner or two, and a nice bright summer day!

State Wins in Shoreland Protection Act Lawsuit

The first of October the DES approved a settlement between the State and a defendant to resolve violations of the State's shoreland and wetlands laws. The settlement imposes a \$40,000 penalty on the defendant, \$25,000 of which will be paid to the State and \$15,000 of which will be permanently suspended if the defendant does not violate the settlement or State environmental laws again within three years of the entry of the settlement agreement.

In its lawsuit, the State alleged that the defendant violated the Comprehensive Shoreland Protection Act and State wetlands laws by constructing a retaining wall along Arlington Pond and by constructing a large stone patio, firepit, stairway, and other structures all within the zone protected by the Shoreland Act. In order to resolve the lawsuit, the defendant restored all of the areas that the Department determined were altered without authorization. This included the complete removal of all items that could not be approved.
